
FAMILY GROUP RECORD OF WILLIAM AND MARY GUNNE

William Gunne was christened 4 October 1635 in Tadmarton, Oxfordshire, the son of Richard Gunne. Tadmarton is about five miles east of Brailes. He married Mary.




Brailes

Mary died as a widow and was buried 30 January 1718 in Brailes.




Burial record for Mary Gunn in Brailes:

*3. Elizabeth, christened 7 November 1680 in Brailes; married William Russell in 1704 in Brailes.




Baptism record for Elizabeth Gunne in Brailes: "Elizabeth daughter of William Gunne baptized November the 7"

FAMILY GROUP RECORD OF RICHARD GUNNE

Richard Gunne was christened 18 May 1606 in Tadmarton, the son of William Gunne and Joan Potter.

Richard acted as an appraiser for the inventory of John Cooke in his will of 1640, and signed with his mark.





Richard and his wife had the following children:

- 1. **John**, christened 9 March 1634 in Tadmarton; married Anne; left a will in 1695, naming his wife Anne, sons William and Richard, and daughters Anne Bowers, Mary Alcock and Joane Gilks, brother Richard Gunne of Neithrop in the parish of Banbury, grandson John Gunne and granddaughter Anne Gunne, the daughter of his son John Gunne.
- *2. William, christened 4 October 1635 in Tadmarton; married Mary; buried 27 June 1715 in Brailes.

- 3. Jone, christened 27 May 1638 in Tadmarton; buried 29 August 1643 in Tadmarton. .

- 5. **Thomas**, christened 2 July 1643 in Tadmarton.
- 6. **Richard**, christened 21 April 1651 in Tadmarton, of Neithrop in the parish of Banbury in 1695.

FAMILY GROUP RECORD OF WILLIAM GUNNE AND JOAN POTTER

William Gunne was christened 25 December 1566 in Tadmarton, the son of Robert Gunne and Margaret Petifer. William's father Robert died in 1574, when William was only eight years old. His mother Margaret married again a year later to William Dumbleton of Tadmarton.

William married Joan Potter 14 January 1594 in Tadmarton. Joan was christened 22 October 1570 in Tadmarton, the daughter of Roberte Potter and Marian Joyner.




Marriage record for William Potter and Joan Potter in Tadmarton:

William was mentioned in the will of his stepfather, William Dumbleton in 1593: "I give to Wylliam Gunne a breeder of ij yeres old, a quarter of barly, one payre of sheetes, a platter, a sawcer and a tableclothe."


William was also mentioned in the will of his half-sister Elen Dumbleton in 1609: "I gyve to the children of my brother William Gonne that xls which my said brother doth owe me. Item I gyve to Ellen Petipher five poundes, which said monie I will shall be employed to her use by my mother Margarett Dombleton and my brother Wylliam Gonne until the said Elen shall accomplish the age of xviij yeres...And I ordeyne my brother Wylliam Gonne and ffrannces Thomlynes overseers of the same, to whom I gyve vjd apeece. In the presence of Harry Wylkinson and Wylliam Gonne."

William was a churchwarden in 1617 in Tadmarton.







Joan died and was buried 25 June 1631 in Tadmarton.




Burial record for Joan Gunne in Tadmarton:

William died and was buried 22 November 1637 in Tadmarton.




Burial record for William Gunn in Tadmarton:

Will of William Gunne of Tadmarton, 1637

In the name of God Amn I William Gunne of Tadmarton in the county of Oxon yeoman beeinge weake in body but of perfect memory thankes bee to Allmightie God doe heare ordaine make this my last will and testament upon the eighteenth day of May and in the yeare of our Lord God one thousand sixe hundred thirty and seaven in manner and forme as followeth/Imprimis I give and beequeath my soule to Allmighty God my maker and my body to the earth to bee buried within the churchyard of Tadmarton aforesaid. Item I give unto my sonne William Gunne clarke xijs. Item I give to my sonne Thomas Gunne vijd. Item I give to my sonne Richard Gunne xijd. Item I give to my daughter Alice Baylie xijd. Item I give to my daughter Hanna Coales xijd. Item I give to my daughter Sara Gunne xijd. Item I give to Samuell the sonne of my sonne William xxs. Item I give to Joane and Margarett the two daughters of my sonne William Gunne xxs a peece. All the rest of my goodes and chattelles ungiven and unbeequeathed with the deades yeare my debttes and funeral discharged I give to William Gunne the sonne of my sonne William Gunne whom I make sole executor to this my last will and testament. In witnes whereof I have sett my hand the day and yeare ffirst above written.

FAMILY GROUP RECORD OF ROBERT GUNNE AND MARGARET PETIFER

Robert Gunne was born in about 1535 of Tadmarton, likely the son of William Gunne. Robert married first, Elizabeth Hall 20 September 1556 in Tadmarton.

Elizabeth must have died, and Robert married Margaret Petifer 24 November 1558 in Tadmarton.




Marriage record for Robert Gunne and Margaret Petifer in Tadmarton:

Robert died in 1574 in Tadmarton, and an administration was created for his estate. The administration, in Latin, lists his widow Margaret, and sons Edward and William.




Administration for Robert Gunne of Tadmarton, 1574

Margaret married again, to William Dumbleton 14 May 1575 in Swalcliffe. The marriage was recorded in the Tadmarton parish register.




Marriage record for Margaret Gunne in the Tadmarton parish register: "Marget Gon was maried to William Dombleton at Swacliffe the xiiijth day"

Testament of William Dumbleton de Tadmarton xxv die Augusti Ao Dmi 1593

In dei noie Amen I Wylliam Dombleton of Tadmarton in the countie of Oxon husbandman being sicke in bodie but of good and perfect memorie (thanks be unto God) make this my last wyll and testament in manor and forme folowing. Ffyrst I comend my sould into the handes of Almightie God, hoping to be saved by the onlie meryts of Jesus Christ: And my body to be buryed in the churchyard of Tadmarton aforsayd. Item I gyve to the poore of Tadmarton ijs ijd. Item I gyve to the church of Tadmarton xjd. Item I gyve to Wylliam Gunne a breeder of ij yeres old, a quarter of barly, one payre of sheetes, a platter, a sawcer and a tableclothe. Item I gyve to my daughter Ales Dombleton a breeder of ij yeres old, and ij sheepe, a payre of shetes, a quarter of barly, a platter, a wawcer, a tablecloth to be delivered at the day of her mariage. Item I gyve to my sayd daughter Ales to be delivered after the decease of Margett my wife one yron bound cart and ij of the best cartehorses. Item I gyve to Elesabeth, Margett and Elen my daughters to each of them a breeder of ij yeres, xij shepe, iij platters, iij sawcers, a brassepott, ij quarters of barly, a mattresse, a blanket, a coverlet, iij payre of sheetes to be delivered at their several days of mariage. And if anie of my sayd children shall decease before their sayd day of mariage, then the portions of her or them so deceasing to be devided queally between the survyvors. Item I give to my shepherd xijd, and to every of my godchildren iiijd. All the rest of my goodes moveables and unmoveables I gyve and bequeth to Margett my wyfe whom I make sole executrix of this my last wyll and testament. And I make Mr. Jn Burby and Richard Dombleton my brother overseers of the same. In the presence of John Craiker, John Harries, Richard House, Richard Potter, John Bloxham

Debtes that I owe Imprimis to Mr. Burby – xxvjs viijd Item to **Wylliam Gonne** – iiij li Item to Edward Dombleton my brother – iiij li xijs Margaret died and was buried 21 February 1622 in Tadmarton.



In the name of God Amen I **Elen Dombleton of Tadmarton** in the Countie of Oxon spinster sicke in bodie but of good and perfect memorie thankes be to God doe make this my last will and testament in maner and forme following ffirst I commend my soule into the handes of Almightie God and my bodie to be buried in the church yeard of Tadmarton. Item I give to xiij poore men of Tadmarton iijs iiijd to be equally pled amonge them. Item I give to my god children iiijd apeece. Item I gyve to **the children of my brother William Gonne** that xls which my said brother doth owe me. Item I gyve to **Ellen Petipher** five poundes, which said monie I will shall be employed to her use by **my mother Margarett Dombleton** and **my**

brother Wylliam Gonne until the said Elen shall accomplish the age of xviij yeres. Item I gyve to Wylliam Carter the sone of my sister Elizabeth xxs. Item I gyve to the three children of my sister Davis five shillinges apeece. Item I give to my sister Elizabeth a gowne & a petticotte & to my sister Marget a gowne & a petticote. All the rest of my goodes & chattels I give to my mother Margaret Dombleton whome I make execurix of this my last will & testament. And I ordayne my brother William Gonne & ffrannces Tomlynes overseers of the same, to whome I give ijd appece. In the presence of Harry Wylkinson & William Gune the xiiijth day of ffebruarie 1609."

William Gunne signed the parish register as a churchwarden from the very beginning of the register in 1548. He is likely Robert's father. William continued to be a churchwarden for many years in the late 1500s until 1597.
